*An Ordinance Amending Chapter 304
Park and Recreation Advisory Board*

THE CITY COUNCIL FOR THE CITY OF DUNDAS DOES HEREBY ORDAIN:

SECTION 1. Dundas City Code Chapter 304, "PARK AND RECREATION ADVISORY BOARD", Section 304.03, "ORGANIZATION, MEETINGS, MINUTES", is amended by deleting the words shown in strikeout and adding the underlined words as follows:

§304.03 ORGANIZATION, MEETINGS, MINUTES

(A) At ~~the~~ its first regular meeting ~~in January~~ of each year, the Park and Recreation Advisory Board shall elect a Chairperson, a Vice-Chairperson and a Secretary from among its appointed members, each for a term of one year. The Park and Recreation Advisory Board may create and fill other offices as it may determine.

(B) The Park and Recreation Advisory Board shall ~~hold at least one meeting each month~~ meet as necessary, at the time and place as they may fix by resolution. Special meetings may be called at any time by the Chairperson, or in the case of the Chairperson's absence, by the Vice-Chairperson, in accordance with the Minnesota Open Meeting Law. ~~A minimum of three days notice is required for posting purposes.~~

(C) Written minutes shall be kept and filed with City Administrator. ~~prior to the next regularly scheduled City council meeting, but shall be subject to the approval at the next Park and Recreation Advisory Board meeting.~~

SECTION 2. This ordinance becomes effective from and after its passage and publication in accordance with law.
