**ORDINANCE 2014-05**

*An Ordinance Amending Title 3 Administration, Chapter 300 City Council  
General Provisions, Section §300.08 of the Dundas City Code  
Relating to Compensation of Mayor and Council Members*

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DUNDAS:**

**SECTION 1.** Section § 300.08(B), Chapter 300: "GENERAL PROVISIONS" of the Dundas City Code is repealed in its entirety and is replaced with a completely new Section § 300.08(B) as follows:

B) The salary of the Mayor shall be \$500.00 per month. The salary for City Council Members shall be \$400.00 per month. Salaries shall be paid monthly and include payment for attendance at all meetings and committee assignments throughout the month. The City Council may authorize reimbursement or the payment of per diem to Council members, for attendance at conferences and training seminars, on an individual case-by-case basis.

**SECTION 2.** This Ordinance is effective upon its passage and publication in accordance with law.

**BE IT FURTHER ORDAINED BY THE CITY COUNCIL FOR THE CITY OF DUNDAS:**

1. Salary increase for Mayor and City Council will become effective on January 1, 2015.
2. The attached Summary of Ordinance 2014-05 is hereby approved for publication.
